Frequently Asked Questions

1. When are your town board meetings held?

- a. The Town of Koshkonong's monthly meetings are usually held on the 2nd Wednesday of every month at the Town Hall located at W5609 Star School Road, Fort Atkinson, WI 53538.

2. Who do I contact if I have questions about the town or any town related items?

- a. We always encourage you to reach out to any Supervisor or contact the Town Hall for anything that we may be able to assist with or provide direction about. You are always encouraged to join us at the monthly Town Board Meetings where there will be time for public comment available.

3. Where are, your meeting agendas posted at?

- a. We physically post an agenda in 3 locations. The first being the kiosk next to the door of the Town Hall located at W5609 Star School Road, second the median of South Main in the Thornapple subdivision, the third in the kiosk on the tree by the intersection of Potawatomi Trail and Oxbow Bend. In addition to these we also post in on the front page of our website, <https://koshkonongwi.com/>

4. Do I need a permit?

- a. There are many items that permits are required for our Township (i.e. driveway construction/reconstruction, and fence; some are distributed through Jefferson County and some from the Town. If you have any questions, it is always good to contact the town for more information regarding them.

5. Where can I see the Town Ordinances?

- a. We are working to get them scanned on our website for the short term that they can be referenced. Long term we are working with a company to get them listed and searchable by type, we are very excited to offer this capability when complete.

6. Do I need a building permit?

- a. Contact the Town Building Inspector, Greg Noll, at (920)675-9062 for more information on building permits.

7. Do I need a burning permit?

- a. Any open burning must be reported to the sheriff's office. The town no longer requires for you to contact them. Click here for details regarding our burning ordinance. (link to burning information?)

8. What do I do with discarded items that do not fit in my garbage or recycling bin?

- a. Bulk pick up days are the 3rd week of your scheduled garbage pick-up days. You may place item(s) curbside on bulk pick up days. For large or heavy items, please contact Badgerland Disposal to notify them of the items you are putting curbside.

COLLECTION PROGRAM REMINDERS:

- Trash and recycling must be curbside by 6:00 a.m. on your designated collection day,
- Cart Placement: *Containers must be 3 feet apart & 3 feet from any obstruction*, walking between containers is a good rule of thumb. Or, place one container on the left side of the driveway and the other container on the right (see below diagram),



- Please ensure all materials are placed inside your container and properly secured to prevent litter,
- **PLEASE ENSURE ALL CARDBOARD IS BROKEN DOWN AND INSIDE YOUR CONTAINER**
- One-day service delay on holiday weeks (see attached calendar),
- Carts remain the property of Badgerland Disposal. Residents may be required to pay for replacement carts if damages are due to negligence or abuse,
- Please do not take containers if you move.

Items that **CANNOT** be placed in the **trash** container: Dirt, sod, concrete, rock, construction or demolition debris, household hazardous waste, banned electronic waste, animal waste, leaves, grass clippings, hot ashes or flammable materials such as oil, gas or paint, batteries, engine parts or tires.

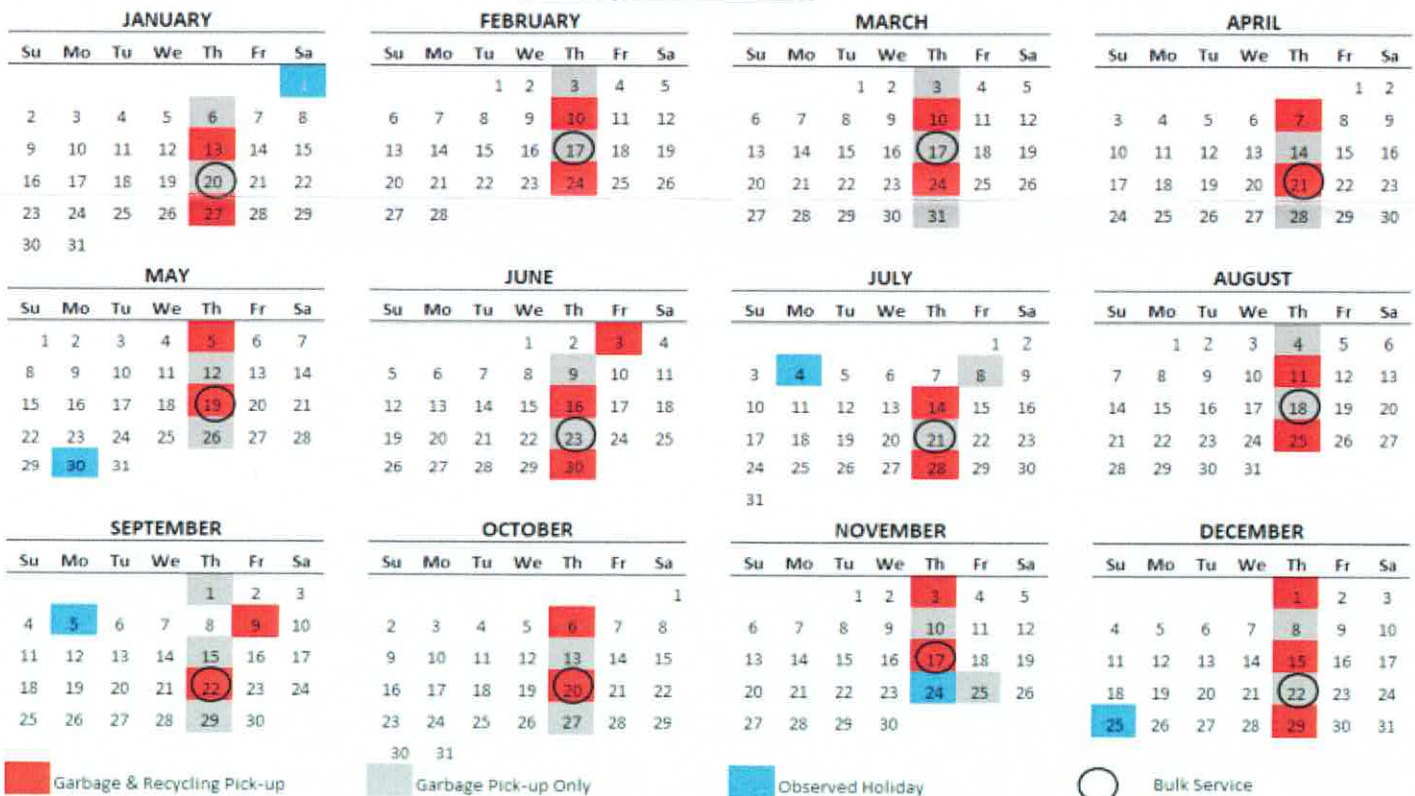

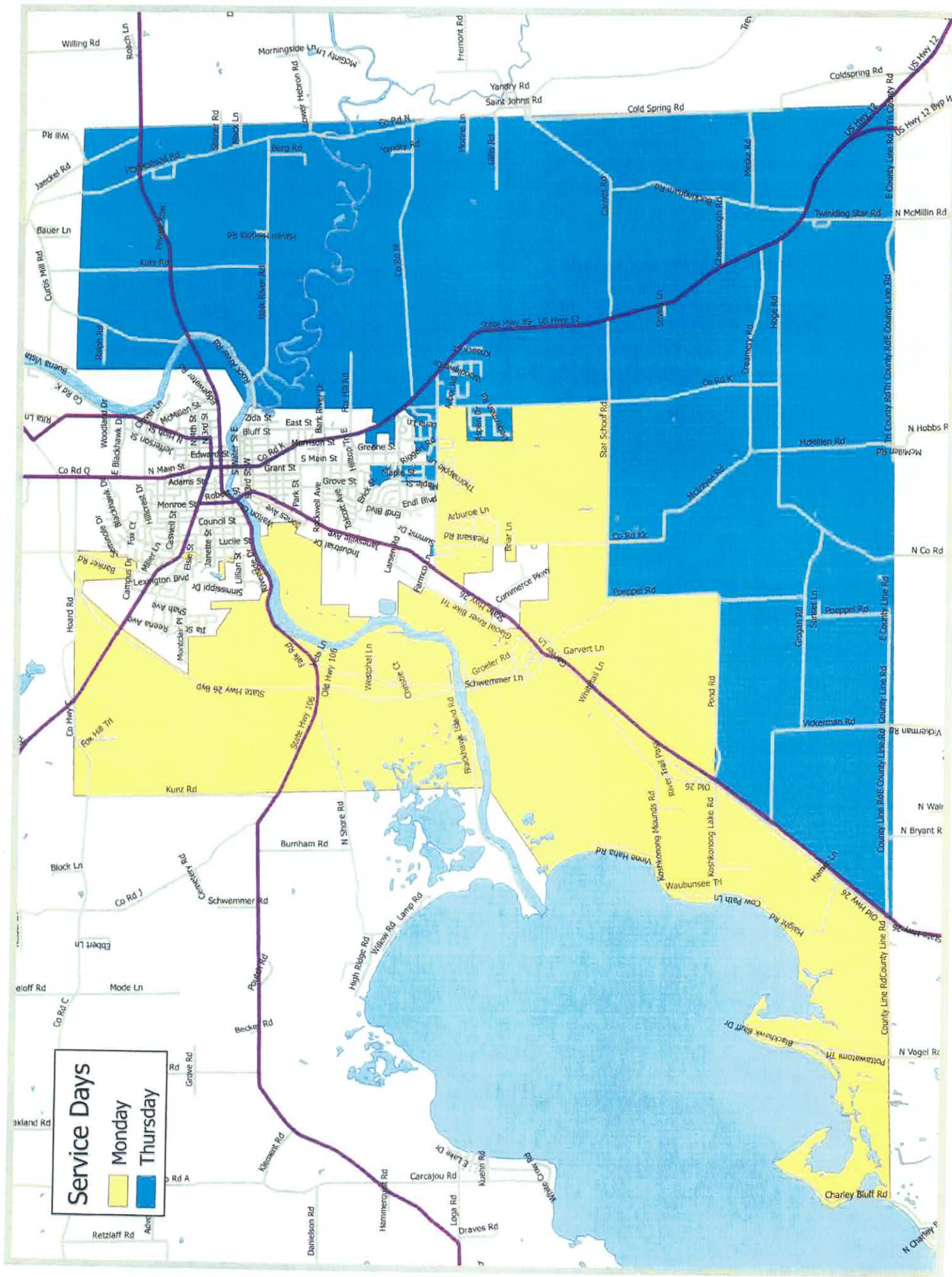
Monday Service Calendar

DOG LICENSES

State law requires all dogs over 5 months of age be licensed annually. Fill out the dog license form below and mail it, along with the payment, to the town hall. It is due by March 31, and a \$10 late fee will be charged for any dog not licensed by then. Fees are \$15 for each dog, but is reduced to \$10 if it is spayed or neutered. Unlicensed dogs are subject to a fine. Please, do not let your dog run at large, and clean up after your dog when it does its business on any property that is not your own. If you have renters, please give them this information. Dog License Form Include a copy of the RABIES CERTIFICATE if your dog is new or has been vaccinated within the past year. No late fee is imposed for new dogs who become eligible for licensing after March 31. Enter number of each type of dog:
